The Unit Chair position has become a lot of work; I want members to feel I am there for them when they need me.

**Discussion:** Executive wages in this years 2024 Budget where solely based on 'regular' Union release time, no "flexible" or emergency time was allocated. This motion would allow for each Executive position to have up to 5 days throughout the year to use towards Union release time. Budgeting for this time in advance is easier then getting pre approval from the membership as it's usually for unforeseen/unexpected union business that comes up and because we only hold 4 General meetings per year. A question was asked about accountability and informing the membership of days taken. **Actions:** When an Executive member wishes to use one of their 5 union release days, they will inform the rest of the Executive prior to the date and reasons for needing the day.
