Section 4 GENERAL MEETINGS

d) Out of town Unit mileage for use of a personal vehicle to attend General or Special Meetings shall be allowed on a capacity/occupancy ratio of 1:3 (1 person in vehicle = 1/3, 2 persons in vehicle = 2/3, 3 or more people in vehicle = 3/3) of the mileage rate as is applicable under the CUPE BC Expense Policy.

Section 8 OFFICERS

The officers of the Local shall consist of a President, 1st, 2nd, 3rd Vice-Presidents, Recording Secretary, Secretary Treasurer, Unit Chairs (NOYFSS, John-Howard Society, School Districts 53, 67, 83), and three (3) Trustees.

ADD: All officers must give all properties, assets, funds and all records of Local 523 to their successors at the end of their term of office.

Section 9 EXECUTIVE BOARD

- a) The Executive Board shall consist of the President, 1st, 2nd, 3rd Vice-Presidents, Secretary Treasurer, Recording Secretary, and one Unit Chair elected from each unit. Names of Unit Chairs to be forwarded to the Recording Secretary immediately following the election. The delegate executives named shall not be a Trustee of the Local.
- i) The Executive Officers shall hold title to any real estate of the Local as trustees for the Local. They shall have no right to sell, convey, or encumber any real estate without first giving notice and then submitting the proposition to a membership meeting and having it approved.

Motion: To amend CUPE Local 523 Bylaws as indicated below: m/s/c

Section 10 PRESIDENT

The office of the President shall be bonded for not less than ten thousand dollars (\$10,000.00) or as such other greater sum as may be decided at a special meeting, through the master bond held by the Canadian Union of Public Employees.

ADD: The President or designate shall introduce new members and conduct them through the initiation ceremony.

The President shall preside at all meetings of the Local, sign each order on the treasury only as authorized and ordered by the Local; appoint all committees not otherwise ordered; and transact such other business as may of right pertain to the office of President, and which may be necessary for the proper functioning of the Local.

The President, or designate, shall be ex-officio to all committees.

Motion: To amend CUPE Local 523 Bylaws as indicated below: m/s/c

Section 23 GRIEVANCE COMMITTEE

The Grievance Committee shall consist of the 1st Vice President (Chair), Unit Chair(s) and Shop Steward(s) involved with the grievance. The Grievance Committee may appoint additional member(s) if their expertise is needed.

The Grievance Committee shall be responsible for the completion of official grievance forms. Appendix "J".

The Chair shall submit all grievances to the Executive Board for approval prior to settling the grievance or referring it to arbitration.

ADD: The grievance reports shall be presented to the Executive Board and membership and shall also be provided to national representative.

CUPE National Representative shall be an ex-officio member to this committee.

Motion: To amend CUPE Local 523 Bylaws as indicated below: m/s/c

Section 32 ELECTIONS

- a) For the purpose of conducting the Annual Elections, the President shall, subject to the approval of the members at a General Election Membership Meeting appoint a Returning Officer and assistants who cannot be candidates for office nor existing Officers of the local. They shall be members in good standing and not candidates for office. The CUPE National Representative may be appointed as returning officer.
- m) The terms of office shall be:
 - President two years;
 - 1st Vice President two years
 - 2nd Vice President two years
 - 3rd Vice-President one year:
 - Secretary Treasurer two years;
 - Recording Secretary two years;
 - Unit Chair two years;
 - Shop Stewards two years;
 - Trustees shall be elected for terms as set out in Article B.3.10 B.2.4 of the CUPE Constitution.

APPENDIX "D" CONTINUING EDUCATION BURSARY

A continuing education bursary of \$400 per student will be paid to applicants to a maximum of **eight** twelve thousand dollars (\$12000) per year for the Local. This bursary shall be offered by CUPE Local 523, to students who are proceeding to a program of studies in any field, whether academic or vocational, within eighteen (18) months of their high school graduation.
