## **Presidents Message**

It is hard to believe that we are already coming into November. This fall seems to have gone fast and it feels like it will be going faster as the days go on. This year is going to be a busy one for all our units. Through this pandemic, the executive continues to do the work of the union and support our members while preparing for bargaining for all 5 units.

I encourage all our members to stay involved in your union, you are the union. Attend school board meetings, look at our website and bylaws about being a steward or sitting on a committee. Reach out to your unit chairs to see what help they may need, and to find your perfect fit.

The role as president is a large one. The question from members keep coming up about how much I work as president as well as the rest of the executive. The role as president is a full-time role and one that I am loving and learning daily. I enjoy navigating and finding ways to support our members while educating myself to affectively do this role.

As president of the local, I am a full time book off which equals the number of hours I work within the district. The motion reads as "That local 523 book off the president based on their regular hours (including temporary hours) and their hourly rate of pay." Depending on the position held with the Employer, whether it is a 10-month or 12-month position, the Employer also does not pay for the time, it is the union that pay for this book off. I wanted to share with the members, that the hours I hold as president is 5.92 hours a day (not including pro d days, Christmas, and March break as well as the summer months July and August). This role as president is between 8-13 hours a day, depending on the day. A book off really means that I am booked off from my regular job with the Employer to do the work of the Union. I am trying to find a balance within each day to continue to spend time with my supportive family, friends, our dog as well as doing things that I like doing, for example scrapbooking. I want to thank all of you for your patience and understanding with all the executive as we also navigate through these busy times with you.

Each of us executive members end up doing a lot of volunteer time to support each of our members. The Unit Chairs do typically take a Union Day once a week to get the job of the union done, however they do end up volunteering a lot of their time after work and on weekends. We get paid the same as you and we work the same hours as you, we are paying union dues just like you and I thank you for being mindful of the number of hours and dedication that each executive member puts into their roles. I want to thank the executive as they navigate through this busy time while trying to maintain balance in their life and rejuvenating themselves. Thank you again to our members for your patience and understanding through these times.

Lastly, to all the members who sit on a committee and who are shop stewards within your units. Thank you for volunteering your time on these committees. You play an important role within the union that doesn't go unnoticed. The executive is thankful for your willingness and dedication and are greatly appreciative.

I would like to personally invite you to our next general meeting which will be held online over teams. Saturday November 6th from 10-12. If you are a new member, at this meeting you can get

## Occupational Health and Safety (OH&S)

There have been many things happening around health and safety in the local and units. If you have been going through some challenging times and need to talk to someone, there are options for you. Every member has access to help and I encourage you to reach out to your unit chair for this information.

Also, each worksite has a health and safety team to go to if you need to bring any health and safety concerns to or get some answers. These committees play an important role not only for the sites but for all our members.

If you are interested in health and safety, please reach out to your Unit Chair to get more information.

**Did you know** that each unit has elected local health and safety representatives who meet every 2/3 months and discuss heath and safety issues in the workplaces within each site? Your unit is represented at these meetings. Thank you Team!!!

**Vaccine Policies** – With the COVID-19 vaccine mandate likely to come within the public education setting. The union continues to engage with the Government to ensure that any mandate is not implemented district by district instead guided as provincial approach and done equitably for all workers in public education. This is about keeping everyone safe. You, your family, your co-workers, and the students in what is a very unique, not to mention complex time for worker safety and the protection of public health.

While no mandate has been announced yet, by either the Public Health Office (PHO) or district employers, the union is being proactive and is engaging with the Government to ensure that policies or mandates that come are fair, equitable, and have due process that applies to all members. In preparation for possible K-12 system vaccine mandates, the Ministry of Education held the first meeting with The Advisory Committee on K-12 Sector Vaccine Policies. The Committee is comprised of one (1) member from numerous organizations, CUPE being one of them.

CUPE locals representing workers in the B.C. K-12 education system are ready to work with school districts and the provincial government to ensure any immunization plans are effective, efficient, and respect the rights of K-12 school workers.

An employer cannot force you to get vaccinated and only you can make the vaccine choice for yourself. However, the decision to not get vaccinated can have employment consequences as an employer can make workplace rules about vaccination and other protective health measures.

We don't know yet what a mandate could or will look like, or what the process will be for exemptions. Any mandate needs to be done equitably and consider possible accommodation process for those who have a bona fide exemption.

We are committed to ensure that any process applied to members includes clear exemption criteria (for example, those with medical exemptions) and how they will then be accommodated. We know this present uncertainty is difficult but cannot provide more information on what may be required to demonstrate a legitimate exemption until this potential mandate is in place.

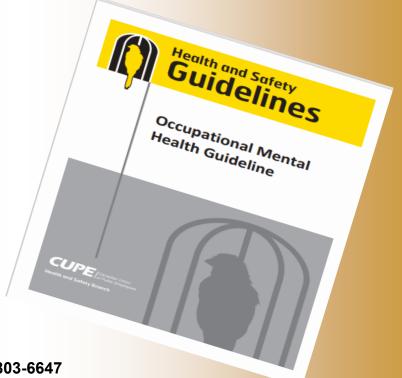

### **Education**

# **NATIONAL DAY FOR** TRUTH AND RECONCILIATION

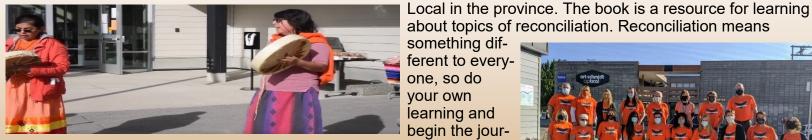
### **September 30 Truth & Reconciliation Day**

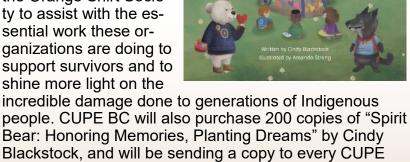

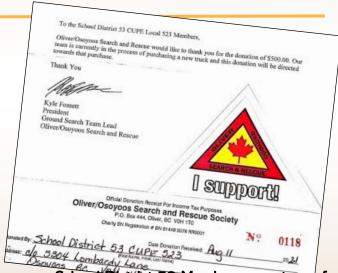
