President Report – President Report for members May 2024

Dear Members,

Since the last General meeting, we have had a special meeting to discuss bringing in another unit into Local 523. I am pleased to announce that the members who attended the meeting voted to accept the Inter-Facility Transit members into Local 523. This unit has no collective agreement, and this is an area that we will be working with the members as well as their Employer in negotiating a contract. I look forward to working with all the members and supporting them through this process. Welcome to Local 523.

The last couple of months have been busy, from meetings with management, members, grievance meetings, convention activities, meetings with other locals, and attending a lawyer conference. These are just a few things that have been taking place.

The lawyer conference I attended was where lawyers and arbitrators discussed current case laws. This was particularly beneficial and useful, especially as it pertains to grievances that are approaching the arbitration level. Hearing about case laws involving issues like those our members face in grievances is always advantageous.

Joint Labour Management meetings continue to happen in the units, and I have been attending these to support the Unit Chairs and members. Supporting the Unit Chairs at these meetings is just one area of the assistance we the executive provide.

CUPE BC Convention

The CUPE BC Convention took place in Vancouver this year and had about 500 people in attendance from across many different locals. The convention involved full days of discussing, debating, and voting on resolutions brought forward by members. Resolutions can either amend the constitution or provide CUPE BC with a direction to work towards on behalf of the members. Attendees of the convention discuss, debate, and vote on these resolutions and constitutional changes, keeping the interests of all members in mind. This year, 44 resolutions and 2 constitutional amendments were passed, while 4 constitutional resolutions were defeated. There was a healthy debate throughout the convention.

Bargaining Updates

Bargaining has already begun in the local for all units. Meetings with past bargaining committees and finalizing the new bargaining committees for each unit are well underway. Strategic planning sessions have also begun with the assistance of the National Representative. Please watch for updates in the fall around bargaining and if you want to get involved there are many opportunities that we would welcome. Please reach out to your unit chair for more information.

Spring has been busy in all our units, with investigations, grievances being filed and proceeding through the grievance process. Spring layoffs in the school districts keep the unit chairs extra busy. Investigation meetings also keep all our unit chairs, 1st vice president and I busy as we navigate through the process and file grievances where we need to. As we continue to navigate through the spring and begin to set our minds on summer and the plans we have, I am hopeful that everyone finds time to enjoy each day and the moments they offer us.
